SPECIAL PRESENTATION

Mrs. Kritzman shared information regarding the Washtenaw ISD Special Education millage proposal and how it would benefit all students in Washtenaw County. Mrs. Kritzman added that Whitmore Lake could receive an estimate of \$453,000 if the millage passes. Additional information can be found on the WISD website.

Superintendent DeKeyser shared the millage would aid both general fund and special education as the dollars allocated from the general fund to cover the special education expenses would go back into the general fund to continue other programs.

COMMITTEE REPORTS

Mrs. LaForest shared that the Finance Committee met earlier this evening. They discussed the preliminary budget for 2016-17 and the renewal request of 18 mil non homestead tax and renewal of 2 mil Headlee override which is on this evening's agenda.

Overnight Trip Proposals

Tax Renewals

Motion to approve the renewal request of 18 mil non homestead tax and renewal of 2 mil Headlee override on the August 2, 2016 ballot was made by Mrs. Slagle; supported by Mr. Henry.

Superintendent DeKeyser shared that the 2 mil Headlee override is required by law. It allows for the variation in the cost of living and caps the amount that can be asked. This is a renewal request for non homestead and would be for 10 years.

**NEOLA** 

Superintendent DeKeyser shared NEOLA policy 6620 states that the board shall have a fund balance of 10%. Early Warning Legislation states a school district should have 5%. Updated language would be brought back for a second reading.

Mrs. Slagle and Mr. Henry suggested updating the language to read the board shall strive for minimum target fund equity of 5% of revenue.

## SUPERINTENDENT REPORT

Superintendent, Tom DeKeyser, shared the following:

- 1) Sinking Fund Previous discussion with the Finance Committee on adding a Sinking Fund on the August Ballot.
- 2) Thursday, April 21, 2016 the Washtenaw ISD is presenting their budget. If anyone can attend let him know and he'll provide more information.
- 3) The billboard on US-23 is displaying our upcoming drama presentation.
- 4) Mrs. Schwennesen shared that the Robotics Team did not advance to the World Competition. However overall they placed 70<sup>th</sup> with about 400 teams competing in Michigan putting them in about the top 15%.
- 5) Secondary School very active spring season with all sports, prom is the weekend of April 30, graduation notifications are going out, and this weekend our drama club will be performing Beauty & the Beast on Thursday, Saturday and Sunday.

## **Building Level Report**

Elementary Principal and ECC Director, Sue Wanamaker, shared that this Thursday, April 21, 2016, the elementary will be having a recycling family fun night, Friday, April 22, they are hosting Caricature Tea for the promotion of Beauty & the Beast, and on April 29 they will have an Invention Convention instead of the traditional Science Fair.
