**CALL TO ORDER**

APPROVAL OF AGENDA

**BUDGET HEARING** 

Director of Finance & Operations, Denise Kerrigan reviewed the proposed budget recommendations for the 2019-2020 school year. Mrs. Kerrigan shared the budget reflects a decrease in ACT 18 funding and Medicaid Proceeds and an estimated state foundation increase of \$110 which has not been approved in the state budget. She also shared the budget is projected to end with a 6.0% total fund balance.

Mr. DeKeyser shared the 2019-2020 includes spending for new buses. Mr. Meadows inquired on grant funding for buses that WLPS may qualify for.

Mr. Dignan shared his disappointment with the Food Service expenditures requiring funding from the General Fund.

Mrs. Kritzman shared the Finance Committee met on June 6, 2019. She shared they did an in-depth review of the 2019–2020 budget and discussed the 2018-2019 Food Service Budget. Mr. Dignan shared the Executive Committee met on May 28, 2019. Topics of discussion included review of superintendent contract, and the Community Recreation Millage information video.

Mr. Henry asked if 6<sup>th</sup> grade students will participate in middle school sports during the 2019-2020 year. Mrs. Kerrigan shared they can participate in some of the sports and Whitmore Lake Elementary will be added to the Schools list on the resolution.

Motion to approve the 2019-2020 Athletic Training Management Agreement with MedSport, a Program of the Regents of the University of Michigan was made by Mr. Henry; supported by Mr. Meadows.

Mr. Cole questioned if they are certified Athletic Trainers. Mrs. Kerrigan answered yes they are.

2019-20 Contracted Services Contract

Motion to approve the 2019-2020 Server Maintenance and Network Infrastructure Support Services with Washtenaw Intermediate School District was made by Mr. Meadows; supported by Mr. Cole.

Superintendent DeKeyser shared we've had this agreement with the WISD for multiple years, the new WISD Director of Technology decided to revamp the contract. Mrs. Kerrigan shared in the past it was a set yearly rate. The contract splits it out into a monthly base service rate plus an hourly rate for additional services requested.

Food Service Meal Price Proposal

Mrs. Schwennesen led Board members into a discussion to consider a price increase on the breakfast and lunch purchased meals. She also shared there has not been a price increase in last 15 years. Mrs. Kritzman and Mrs. McCully noted the highest increase of .50 cents is for the specialty lunches, with a .25 cent increase for the regular hot lunch offered at the high school.

Motion to increase breakfast from \$1.60 to \$1.75at the ES & MS/HS, the MS/HS regular hot lunch from \$3.00 to \$3.25, and the MS/HS salad bar and

Panini lunch from \$3.00 to \$3.50 as presented made by Mr. Dignan; supported by Mrs. McCully.
