Fiber Consortium Agreement

Motion to approve the Fiber Consortium Master Service Agreement with the WISD for the FY22-23 through FY27-28. The WISD fiber network owned and operated by WISD on behalf of all constituent districts made by Mr. Cole; supported by Mrs. Kritzman.

Mr. Meadows inquired if this agreement is the same as we have done in the past. Superintendent DeKeyser shared we have an agreement for bandwidth and pay for certain services, however this agreement is more detailed and contains provisions for protection and defined rates. He then answered additional questions from Board members.

Mrs. Schwennesen shared her thoughts regarding the length of the agreement. A discussion by Board members began regarding no exit clause in the contract.

Motion to withdrawal the original motion to approve the Fiber Consortium Master Service Agreement with the WISD for the FY22-23 through FY27-28 until additional information regarding an exit clause prior to the end date, if necessary, is available was made by Mr. Cole; supported by Mrs. Kritzman.

Motion to approve the hire of Teren Sechrist as a full time High School Special Education Teacher at step 1 on the WLEA BA salary scale with a hire date of March 16, 2022 and a start date of April 6, 2022 was made by Mr. Meadows; supported by Mr. Cole.

- Attended budgetary meetings last week, Governor proposes \$435 per pupil increase, 2022-23 budget for stable enrollment, added expenses: additional buses, pavement repairs, need for a nurse, school resource officer, class size reduction plans, and compensation increases.
