SPECIAL PRESENTATION

Students from the Early Childhood Program performed a song for the Board of Education in the High School Theater.

SPECIAL PRESENTATION

Beverly Bonning, Attorney with Thrun Law Firm, and Greg VanKirk and Marvin Sawyer from Plante Moran CRESA, shared a draft of the school bond proposal. Mr. VanKirk expressed that the taxable value has increased which will help provide the district additional bond money if it passed.

Beverly Bonning shared a timeline along with possible ballot language and resolution for the bond.

Mr. Dignan questioned the three phases of a bond and if there were any restrictions. Mr. VanKirk stated that there were not any restrictions; it is a preference for the district.

Mr. Vega expressed the need for the district to have a turf field as a part of the bond. Mr. Dignan stated that if the bond is "critical needs", he does not feel that a turf field and air conditioning in the Middle School gym are critical and cannot support either of them on the bond.

Mrs. LaForest shared with the Board that she recently attended the District Crisis Team meeting. She added that the topics of discussion were the red information folders and a review of the district lock down process.

**Bond Discussion** 

The Board discussed the upcoming bond during the presentation by Greg VanKirk and Beverly Bonning.

## **Budget Discussion**

Superintendent Hart shared that the district needs to cut approximately 1 million to 1.5 million from the 2013-14 budget. She added that if the district adopts a deficit budget it could affect the districts credit rating for the sale of the districts bonds. Mrs. Hart added that both she and the Business Manager, Jill Minnick, are looking at everything to help reduce the budget deficit.

President Slagle suggested that the district consider reorganizing the buildings and administrative staff in order to cut cost.

Mr. Dignan asked Superintendent Hart if the district could consider a retirement incentive in order to save money. Superintendent Hart stated that she will look in to both suggestions and bring a recommendation to the Board at the May 13, 2013 meeting.

#### Custodial RFP

Superintendent Hart shared that the Custodial RFP had closed and there were four proposals that have been reviewed. Mrs. Hart added that by privatizing the custodians, the district would save approximately \$50,000. She added that she will bring a recommendation to the Board at the May 13, 2013 meeting for approval.

Superintendent Hart shared that the trip has been cancelled due to a lack of participation.
